

Shipped Semen Instruction Sheet

The following are Terms and Conditions for breeding Mare to Stallion via shipped cooled semen:

1. The mare owner shall contact KQH Ranch 2 weeks prior to approximate insemination time with payment and shipping information, to include name, express mail address, and phone of the veterinarian in charge of mare insemination. Please remember that a signed breeding contract, all deposits and fees for collection and shipment, and all breeding fees and expenses must be submitted and paid to KQH Ranch prior to making a request for any shipment. All checks must have cleared the bank, and all Pay Pal payments must have also cleared.
2. All shipping charges will be the Mare Owner's responsibility. The shipping charge for a standard overnight delivery is approximately \$50 - \$100. Late Calls for semen shipment will be subject to an additional \$50.00 late fee that must be paid before semen is shipped. All Shipping charges must be paid in full before semen will be shipped to the Mare. Friday shipments are Saturday Fed Ex deliveries and will cost closer to the \$100 fee.
3. Shipment will take place when KQH Ranch receives confirmation from Mare Owners vet that the mare has been checked and is ready to breed within 24 hours. Semen to be ordered by ***phone by 3PM***, the evening ***PRIOR*** to collection day. Make sure you specify the mare's name and type of shipment you need (overnight or counter to counter). Also - ***verify the stallion you are requesting semen from***. You may cancel that shipment up to 7 AM on the day of the shipment with no penalty. The semen may be used ***ONLY*** for the designated mare. KQH Ranch cannot guarantee semen shipment availability for late calls, but will do its best to provide service. Any late calls that can result in a shipment may be subject to a \$50.00 late charge, which must be paid prior to shipping.
4. Until our lab is up and running we will be using another source for collection and shipping. They collect and ship on ***Monday's, Wednesday's and Friday's***. Anticipated lab opening is May 15, 2017.
5. Mare owner agrees to have the mare pregnancy checked by a licensed veterinarian as soon as possible, and will notify KQH Ranch when the mare is checked safely in foal.
6. A Transported Semen Breeders Certificate will be issued for the foal conceived by this mating when stallion fee and all other expenses have been paid in full and mare has produced a live foal by this mating.
